Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £ 0.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

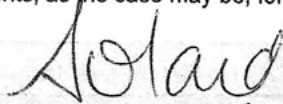

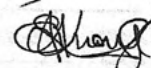

Auditor General for Wales' Audit Certificate and report

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Accounting Statement

I am unable to conclude whether or not the Accounting Statement properly presents the Council's financial transactions and financial position for the year:

- Assertion 1. The Council did not maintain proper accounting records and did not have in place an adequate and effective system of internal control during the year. Therefore I am unable to conclude whether or not the transactions reported are complete and accurate.

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's governance arrangements for the year:

- Assertion 1: As reported by the Council's internal auditor, the Council did not maintain proper accounting records and did not have in place an adequate and effective system of internal control during the year. Therefore, it did not have in place arrangements for effective financial management
- Assertion 3: The Council has not prepared a report required by the Well-Being of Future Generations Act 2015.

Arrangements to secure economy, efficiency and effectiveness in use of resources (value for money)

On the basis of my audit and the disclosures made by the Council, in my opinion, the Council did not make proper arrangements for securing economy efficiency and effectiveness in its use of resources for the financial year 2020-21

- As reported by the Council's internal auditor, the Council did not comply with its own financial regulations.

Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council.

Annual Governance Statement

The proforma Annual Governance Statement sets out the minimum standards of good governance that the Council should adopt. I draw attention to the Council's negative responses to certain the assertions and the additional note attached to the Annual Return. The Council needs to ensure that it addresses all the deficiencies it has identified. I will follow up on the Council's progress at future audits.

There are no further matters that I wish to draw to the Council's attention.
